



## LEGAL AND GOVERNANCE COMMITTEE

- Address legal issues confronting school governing bodies
- Monitor industrial matters and provide advice to the Board and to Governing Bodies of Independent schools.

### MEETINGS

The Legal and Governance Committee usually meets three times per year.

Meetings are held in the AISWA Boardroom, 3/41 Walters Drive, Osborne Park, on Monday evenings and meetings commence at 5.00 pm. Meetings are no more than 1.5 hours in duration.
