

# CLINICAL PSYCHOLOGIST – CARE SCHOOLS

Applications are invited from Registered Clinical Psychologists to work with Independent Schools in WA to provide assessment and intervention for students in our CARE (Curriculum and Re Engagement) schools. Applications would also be accepted from Clinical Registrars with suitable skills and experience.

This part-time, 0.6 (three days per week) full-time equivalent position is available for immediate start and will conclude at the end of June 2021.

#### The Role

The position will be part of a collaborative team at AISWA to assist CARE schools in providing assessment, intervention and referral for students with a range of needs. The successful candidate will carry out psychological assessments to appraise cognitive, emotional and behavioural functioning, i.e. interviews, behavioural observations, psychometric and psycho-diagnostic assessments in accordance with the Australian Psychological Society guidelines. Additional duties may include consultation and support to school staff and parents/guardians of students, liaison with external supports including Mental Health Services and private health professionals and crisis support to schools where necessary.

## Essential Criteria

- 1. Masters Degree in Psychology (Clinical).
- 2. Registration with AHPRA as a psychologist, with endorsement as a clinical psychologist or clinical psychology registrar.
- 3. The capacity to work both independently and within a team of education consultants.
- 4. Experience working with young people, in particular at-risk or disengaged young people.
- 5. Excellent interpersonal and communication skills.
- 6. Working knowledge of the Disability Discrimination Act, Disability Standards in Education and other policy and legislation relevant to students with disabilities in education settings.
- 7. Current Working with Children Check.
- 8. Current Drivers' License.

### Desirable Criteria

- 1. Membership of the APS College of Clinical Psychologists
- 2. Extensive experience in clinical psychological assessment, therapy and interview techniques with children and adolescents.
- 3. Previous experience in an education setting.
- 4. Experience working with children and their families where there are child protection concerns.
- 5. Demonstrated ability to provide intervention for children affected by abuse and trauma.

- 2. If you provide us with personal information, for example, your legal name and address or information contained on your resume, we will collect the information in order to assess your application for employment. We may keep this information on file for a period of up to 60 days if your application is unsuccessful in case another position becomes available unless you advise us otherwise.
