General Teacher Duties

Educational

- teaching duties;

- other activities consistent with the educational task of the College.

- 3. To have or have ability to provide a current and valid Working With Children Check Card.
- 4. To provide a written reference from your Church pastor/minister.

- 1. Personal faith and commitment to the Lord Jesus Christ including regular church attendance and a lifestyle consistent with the expectations of Christian faith.
- 2. Supportive of the aims, principles and tenets of Kingsway Christian Education Association Inc. at Kingsway Christian College.
- 3. Hold academic teaching qualifications that meet the Department of Education requirements for a Secondary Home Economics Teacher.
- 4. Prior successful experience as a Home Economics Teacher (teaching food and textiles) in a Secondary School environment, delivering the Western Australian Curriculum.

- 6. Demonstrated high level inter-personal, problem solving, communication and conflict resolution skills in dealing with students, parents and staff.

- 8. Ability to function and work collaboratively as a member of a Secondary school faculty and with other staff members.
- 9. Able and willing to be involved in the extra-curricular activities offered in the College.
