The Head of Digital Innovation & AI is a newly created strategic leadership role at Santa Maria College, designed to future-proof teaching, learning, and operational excellence through the ethical and creative use of digital technologies, particularly AI. This role is pivotal in shaping a forward-thinking, digitally fluent culture that empowers both staff and students.

Reporting to the Deputy Principal Teaching and Learning and working closely with College leaders, the Head of Digital Innovation & AI will lead the development and implementation of cutting-edge solutions that enhance educational outcomes, streamline school operations, and cultivate a culture of innovation aligned with the College's Mercy values and Catholic identity.

This role is open to both educators and non-educators with relevant experience in digital transformation, innovation leadership, or AI strategy.

- Design and lead pilot programs with staff and students using generative AI and other emerging tools.
- Promote AI literacy and ethical digital citizenship among staff and students.

- Work with ICT to support integration with systems such as SEQTA, Microsoft Teams, OneNote, and SharePoint.
- Develop accessible 'how-to' resources and toolkits for students.

### **Building Staff Capability**

- Develop, promote and facilitate professional learning opportunities for staff in conjunction with the Head of Professional Learning.
- Foster a culture of innovation through coaching and workshops.
- Design professional learning pathways, including micro-credentials for staff.
- Mentor, support, and challenge staff to achieve continuous improvement in the use of technology
- Inspire and support staff to use technology including AI ethically and creatively to reduce workload and increase student engagement.
- Foster a collegial professional learning culture which promotes technology leaders in teams and showcasing of technology strategies.

- Support data-informed decision-making through AI tools and digital dashboards.
- Lead the development of policies related to digital safety, privacy, and ethical AI use.
- Ensure technology practices align with responsible use expectations.
